Massachusetts Cosmetology License

All students in the Commonwealth of Massachusetts must complete the 1000 Cosmetology curriculum mandated by the Massachusetts Board of Cosmetology & Barbering.



Licensing

In order to be Licensed you must successfully complete the 1000 hour program and pass the State License Exam which is both written & practical



Massachusetts Admissions Requirements

Massachusetts Board of Cosmetology & Barbering require that a student be a minimum of sixteen years of age for admission to a cosmetology school.

Cosmetology Apprenticeship Program

At the December 2018 Board Meeting of the Massachusetts Board of Cosmetology and Barbering the Board accepted a recommendation from the Salon Pathway Subcommittee and approved a 1000 hour Cosmetology Apprenticeship Program, an alternative to the current 1000 program.

Cosmetology

The Apprenticeship Program has been designed to offer the Cosmetology Program at an affordable price as well as meet the needs of the Salons by creating Assistant Stylists for Salons



Massachusetts Cosmetology Apprenticeship Program

Students will receive the same curriculum. A portion of the hours for each subject will be in a School and a portion of the hours may be in a Salon. By reducing the minimum number of hours a student must complete in a School, will reduce the student's direct costs.



Massachusetts Cosmetology Apprenticeship Program

Other states offer apprenticeship programs, however Massachusetts is the first state to offer an apprentice program with the same hours as the current state hour requirement. The Massachusetts Apprenticeship Program will allow students to earn money while they are in school preparing for the state examination



Cosmetology

The Cosmetology Apprenticeship Program is a combination of academics and practical training provided by Mansfield and practical experience as a paid apprentice in an approved Salon.



Apprenticeship

A minimum of 600 hours must be successfully completed in school and a maximum of 400 hours of your program may be in an approved salon.



Massachusetts Apprenticeship Program

The Massachusetts Apprenticeship Program :

- Maintains the integrity of the licensing process
- Provides an alternative for students who need a less expensive program and to also work and go to school at the same time.
- Provides an immediate pool of assistants for salons



Minimum Apprenticeship Requirements

The Apprenticeship arrangement must include a Paid-work component (minimum wage) in an approved Salon



Minimum Salon Requirements

Agree to:
Pay Minimum Wage
No more than 2 Apprentice
per Apprentice Supervisor Apprentice
may not be in a in a salon without an
Apprentice Supervisor.*

*waiting for Board language.



Minimum Salon Requirements

Salon must have a Salon Supervisor for every 2 Apprentice . Supervisor must be in attendance when an Apprentice is assisting in any stage of a service.

Apprentice Supervisor must be a Licensee for a minimum of 5 years.*

*waiting for Board language.



Minimum Salon Requirements

Complete and submit monthly reports to the School on the Apprentice's Progress in hours

Supervise Apprentice on tasks according to the Apprentice Progress Report received from school.

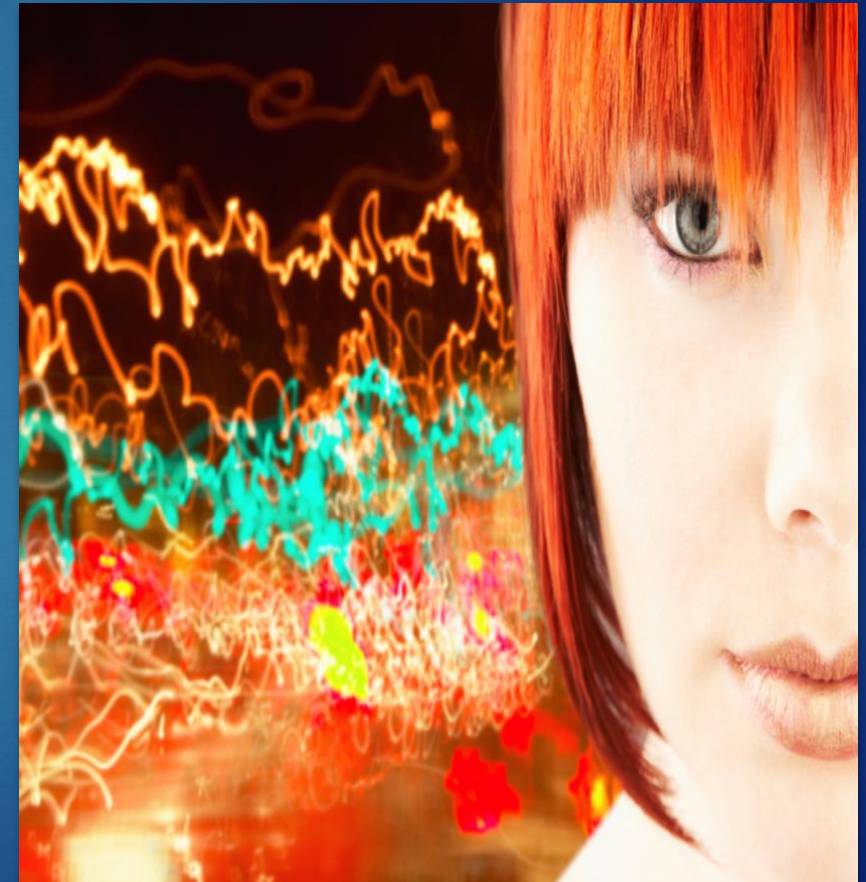
Total Charges
