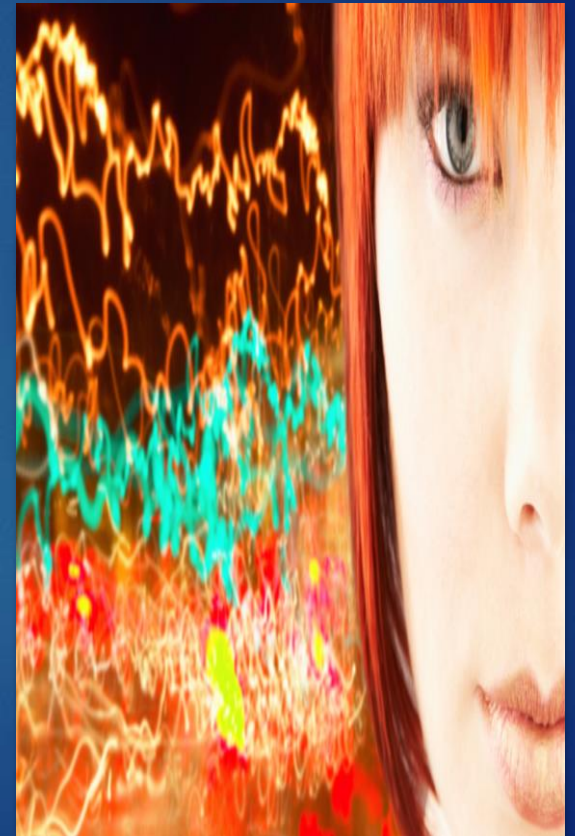


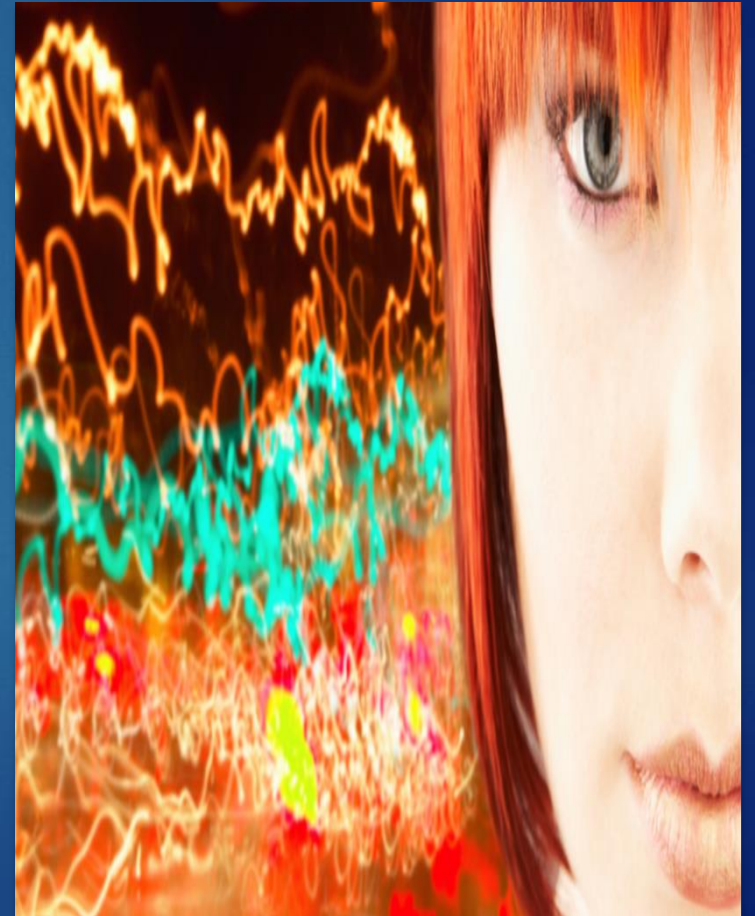
Massachusetts Cosmetology Apprenticeship Program

Massachusetts Board of Cosmetology and Barbering approved a 1000 hour Cosmetology Apprenticeship Program at the December 2018 Board Meeting.



Cosmetology Apprenticeship Program Difference

The Cosmetology Apprenticeship Program provides an alternative method of delivery of the same 1000 hour Massachusetts Cosmetology Curriculum.



Massachusetts Cosmetology Apprenticeship Program

- 1. Maintains the integrity of licensing**
- 2. Provides an alternative for students who need:**
 - a. a less expensive program**
 - b. to work and go to school at the same time**
- 3. Provides an immediate pool of assistants for salons**



Massachusetts Cosmetology Apprenticeship Program Continued

4. Same hours as the current state hour requirement. (Most states double the requirement for apprenticeship.)
5. Academics are provided in school , which better prepares the apprentice to pass state board exam.



Massachusetts Cosmetology License

All students in the Commonwealth of Massachusetts must complete the 1000 Cosmetology curriculum mandated by the Massachusetts Board of Cosmetology & Barbering.



Massachusetts Board of Cosmetology and Barbering Required Curriculum

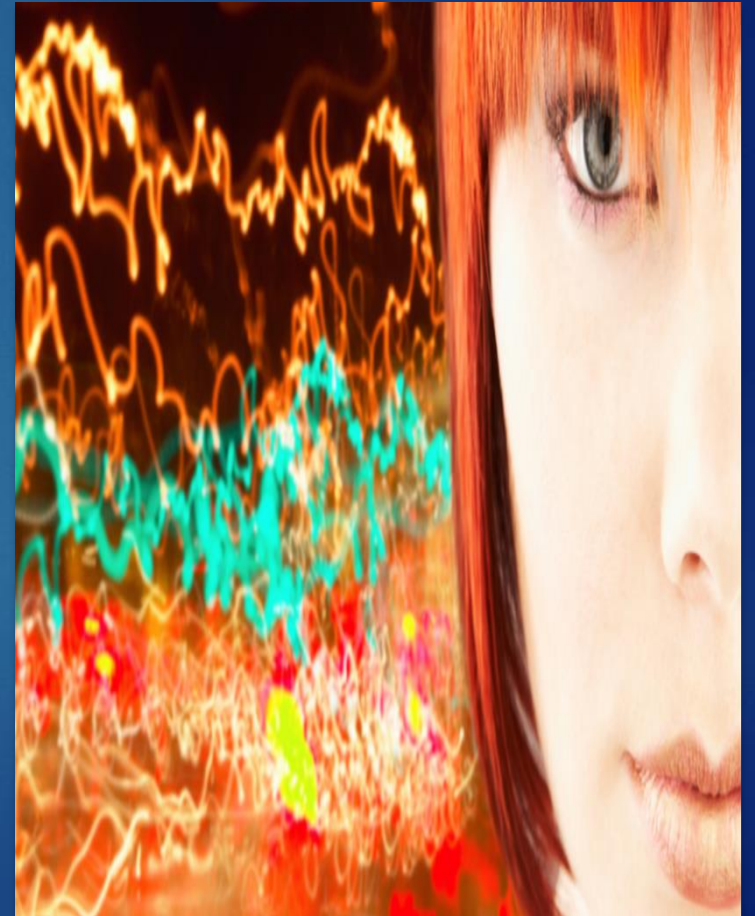

Cosmetology Apprenticeship Program

The Cosmetology Apprenticeship Program leads the student to the same State Board examination for same state licensure which is both written and practical.



Apprenticeship

The Cosmetology Apprenticeship requires a minimum of 600 hours successfully completed in school and a maximum of 400 hours of your program may be in an approved salon.

The student must complete 200 hours prior to receiving credit for hours worked in a Salon.

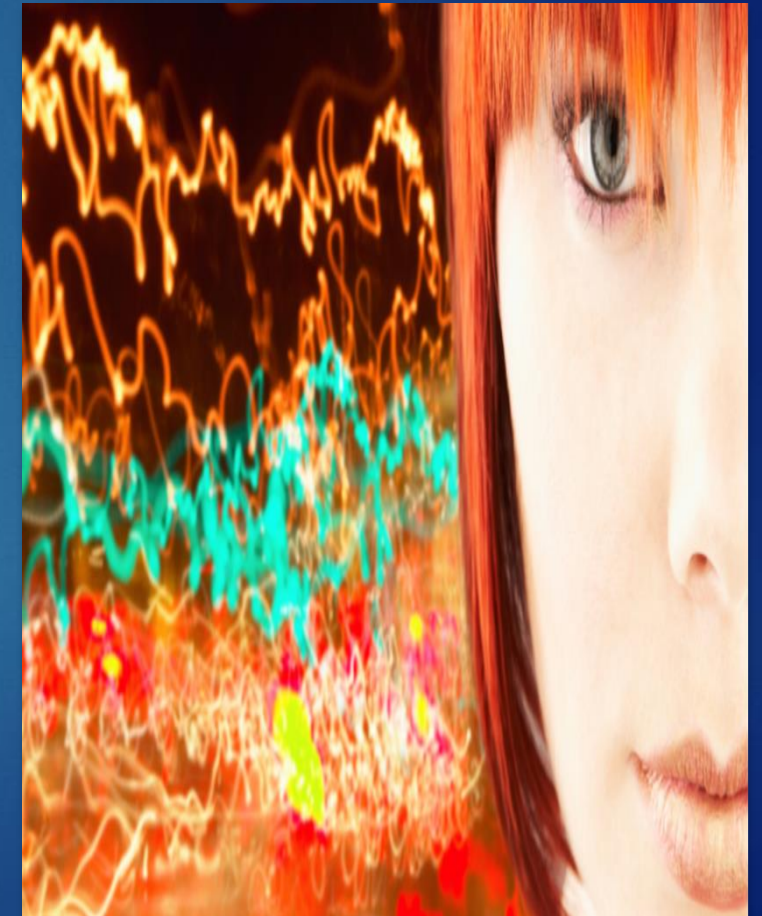


Cosmetology Summary of Program(s)

Program	Cosmetology	Cosmetology Apprentice
Hours in Program	1000	1000
Hours in School	1000	600*
Hours receiving credit in a Salon	0	400**
Hours charged	1000	600

* Minimum number of hours in school 600 may elect to do more

** Maximum hours in a Salon



Minimum Apprenticeship Requirements

The Apprenticeship arrangement must include a Paid-work component (minimum wage) in an approved Salon



Example of Minimum Salon Requirements

Agree to:

- **Pay Minimum Wage to the Apprentice**
- **Salon Supervisor***
- **Maximum number of Apprentice per Salon Supervisor*.**

*waiting for Board language.



Example of Minimum Salon Requirements

- 1. Supervise Apprentice on tasks according to the Apprentice Progress Report received from school.**
- 2. Complete and submit monthly reports to the School on the Apprentice's Progress:**
 - a. hours and date(s) completed and paid at approved Salon**
 - b. Services assisted and or performed in Salon**

Massachusetts Apprenticeship Program Update

As of 03/01/2019 the Apprenticeship Program has been approved, however no school has been approved to offer the program. Therefore Students must still enroll for the 1000 hour program, however Mansfield will allow student's to transfer to the Apprenticeship Program upon approval and will charge students according to the Apprenticeship Program



Massachusetts Apprenticeship Program

Cost of minimum hours to be completed in School:

Tuition: (12.85 x 600)	7770.00
Registration Fee:	50.00
Books:	236.78
Kit:	470.80
Lab Coat:	30.00
Total Charges:	\$8527.00

Students are required to have books, equipment and Mansfield Beauty Schools uniform which may be purchased from the school .



Massachusetts Apprenticeship Program Admission Requirements

Massachusetts Board of Cosmetology & Barbering only requires that a student be a minimum of sixteen years of age for admission to a cosmetology school.
